Store abrasives in dry, frost-free conditions avoiding wide variations in temperature. Ensure they are properly protected and supported to prevent damage und distortion. Coated abrasives should be stored at 18-22 °C, 45-65 % relative humidity.

Before grinding it is recommended to perform a risk assessment and to use personal protection equipment accordingly.
